



Motorplex Autotest

1. Entries:

- 1.1. Limited to a maximum of 50 vehicles.
- 1.2. Entry is open to MX5 Racing WA members competing in the club championship.

2. Event details:

This Autotest will be run on a sealed surface of approximately 1500 to 2000 metres in length with no straight section of more than 140 metres in length without a significant change of direction. The course has been designed to test the acceleration, braking, and general manoeuvrability of the vehicle, along with the skill and judgment of the driver.

The Autotest is to be run as per the layout diagram with a maximum of 3 cars on the layout at any time.

Supplementary Regulations

3. Event type:

This Autotest will use roads and car parking areas at the Kwinana Mototplex complex and here after referred to as the 'Event'.

4. Authority:

The Event will be held under AASA National Competition Rules, these supplementary regulations and any further regulations.

This event will be run under AASA Permit No. **AASA301125-102408**

5. Organization:

The event will be organised by the MX5 Racing WA Inc.

Clerk of Course: Jason Abbott

Event Secretary: Don Messenger

6. Venue:

The event will be conducted on bitumen at the Kwinana Motorplex. Speed should be kept to a walking pace within the pits areas. (Approximately 5 km/h)

7. Entries:

Entries are open to MX5 Racing WA Inc. Members and guests driving a car suitable for tarmac motorsport. Whole Series Entry for MX5 Racing WA Championship Series 2 includes 2 of these events.

8. Cost:

Included in Whole Series Entry Fee (Cost per entry: \$125).

9. Licences:

As a minimum, all participants must hold a current Australian Auto-Sport Alliance "Club racing licence" or an AASA approved equivalent competition licence.

10. Program:

The event shall compromise at least 6 runs with the cut off to be determined by the Clerk of Course on the day. Eight or nine runs are possible, all going well. The score is the sum of your fastest three runs.

The running order is based on ceding rank and modified to cater for the roles of officials.

11. Insurance:

The event permit is effective under AASA. A copy of the terms and conditions are available on the AAS website. The event organisers take no responsibility for a participant's comprehensive and life insurance cover whilst at the event. It is your responsibility to check with your insurer, as your personal insurance may not be valid.



12. Conditions:

- 12.1. Cars shall compete with windows either fully up or fully down.
- 12.2. Re-fuelling, repairs of vehicles and changing of wheels are to be done on cement areas, to protect the bitumen.
- 12.3. A driver whose vehicle has broken down may drive another individual's vehicle, however it must be used for the remainder of the day.
- 12.4. Any vehicle leaking fluids, in particular fuel or oil, must be removed from any bitumen area immediately.
- 12.5. No competing vehicle may leave the venue (meaning the pits and the event course) during the event without permission from the Clerk of Course. Failure to get permission will result in exclusion from the event. No warm up or cool down outside of the venue is permitted.

13. Classes:

If competitors are unsure which class they fit into, they should get official clarification from the Chief Scrutineer well before the event.

Class A = 2-Wheel Drive, Naturally Aspirated up to 1600cc.

Class B = 2-Wheel Drive, Naturally Aspirated 1601 to 2000cc.

Class C = 2-Wheel Drive, Naturally Aspirated 2001 to 3500cc.

Class D = 2-Wheel Drive over 3500cc.

Class G = All guest entrants, including 4WDs.

No SOFT R compound tyres

Forced Induction Capacity Equivalence (FICE) factor = 1.7

14. Vehicle Requirements:

- 14.1. All vehicles competing shall be clean and tidy, road worthy and road registered, unless by prior approval and at the discretion of the organisers. The vehicle must be inspected.
- 14.2. All loose objects must be removed from the vehicle.
- 14.3. We recommend a 1kg or larger fire extinguisher be fitted within easy reach of the driver.
- 14.4. Tyres must be of a type approved for road use (DOT)
- 14.5. Vehicles must comply with the venue/land owners noise requirements and should not exceed 97dBA measured at a point 10 metres from the track edge by approved measuring equipment.
- 14.6. Seatbelts must be fitted to the vehicle and must comply with current Australian Standards.
- 14.7. Scrutiny inspection is required annually and random inspections can occur at any event.

15. Driver Requirements:

- 15.1. Drivers shall wear flame retardant (non-flammable, e.g. cotton) clothing, covering from neck to wrist to ankle (Nylon or synthetic clothing is not permitted) and fully enclosed footwear.
- 15.2. Drivers of cars must wear approved safety helmets as required by AASA or MA. AS1698, BS6658 A/FR, ECE022 04/05, SFI131.1, Snell SA2005 or newer.
- 15.3. Drivers must sign supplied entry/indemnity form and agree to all conditions to compete.

16. Event Layout:

A course map will be published prior to the event. Test markers shall be safety cones.

17. Damage

Any damage you cause or affect is your complete responsibility to remedy in full.



18. Penalties:

“Slowest time” will be based on the fastest time set for the challenge multiplied by 1.333

18.1. A **“slowest time” penalty** may be added for each of the following:

- 18.1.1. Driving the wrong way.
- 18.1.2. Placing any two wheels off the bitumen.
- 18.1.3. Hitting any timing gear.

18.2. A **penalty of 1 second** will be **added to every run** for each of the following:

- 18.2.1. Hitting a cone
- 18.2.2. Driver unnecessarily delaying event
- 18.2.3. Leaking fluids on bitumen area
- 18.2.4. Prolonged wheel spins

18.3. Leaving the track such that a recovery is required can lead to exclusion from the event.

18.4. Behaving in an unsportsmanlike/dangerous manner – disqualification of driver.

19. Protests:

Any protests must be directed to the Clerk of Course without delay and done so in an orderly and polite manner. No protest will be entertained whilst sitting in your car, with a helmet on or an engine running. On the day, the determination of the Clerk of Course is final. Any abuse of officials or competitors during the event will result in exclusion from the event and be referred to the club committee.

20. Alcohol and drugs:

Driving under the influence of drugs or alcohol and consumption of alcohol by drivers is forbidden in accordance with NCR and the Anti-Doping Policy. Consumption of alcohol is forbidden until the conclusion of the meeting. MX5 Racing WA enforces a zero-blood alcohol limit and random breath testing may occur at any time on the day. Any Driver found over the zero limit will be asked to leave.

21. Passengers:

Passengers are NOT allowed.
